Investment objective

The Fund objective is to achieve a positive total return (income and capital growth) over a rolling five year period, after the deduction of all fees, whilst targeting volatility (i.e. the degree of fluctuation of the value of the assets) of its portfolio of between 70% and 80% of the volatility of the FTSE All Share Index over the same rolling five year period. Although the Fund aims to deliver a positive total return over a rolling five year period, there is no guarantee that this will be achieved over this time period, or any time period.

Market commentary

Equity and bond markets lost ground in August due to strong US growth. Ordinarily this may be taken as good news, however this alongside sticky inflation leads to the prospect of interest rates remaining "higher for longer". Thus, bond yields for the US 10-year Treasury and UK 10-year Gilt reached cycle peaks of 4.33% and 4.74% respectively, offering an attractive entry point for investors given the belief that economic growth will succumb to the effects of substantially tighter monetary policy going forward. Profit-taking occurred after a strong period of performance, due to better-than-expected Q2 corporate earnings and investor sentiment improving by late July. The Technology sector maintained good levels of growth, whilst the Resource sectors' profits were hit by commodity price retrenchment. Later in August, Central bankers convened for their annual Jackson Hole symposium. The broad message was one of maintained vigilance over the threat of inflation, with the target of 2% annual growth in consumer prices confirmed.

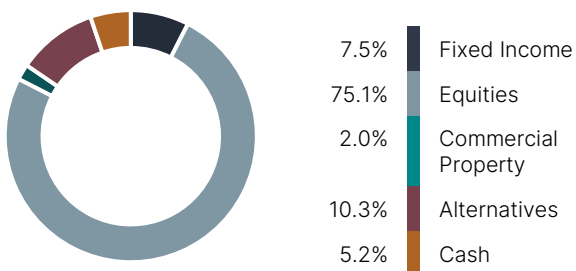
Fund Manager commentary

The fund underperformed the benchmark over the period, with the major asset classes producing negative returns. As expected, in a risk off environment, Alternative assets held up the best. There was positive contributions from JP Morgan Global Macro Opportunities fund, together with some of the infrastructure names including HICL and International Public Partnerships. The mega cap growth stocks in the US continued to climb in August, with Nvidia again delivering excellent results which saw their share price rally. Alphabet, Amazon and Adobe all performed well. Estee Lauder continued to struggle on the back of weak quarterly figures, whilst Financials in general struggled across the board, with HSBC one of the biggest single detractors to performance. UK gilt exposure contributed positively to the FI exposure, but this was not sufficient to counter negative returns within corporate bonds. Property assets experienced a mixed performance, with Triple Point Social Housing giving up some of the previous months gains but UKCM rallying on the back of a period of share price weakness.

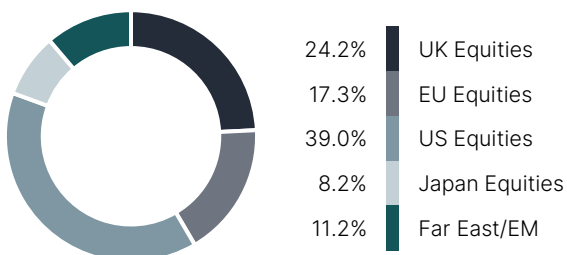

Asset breakdown



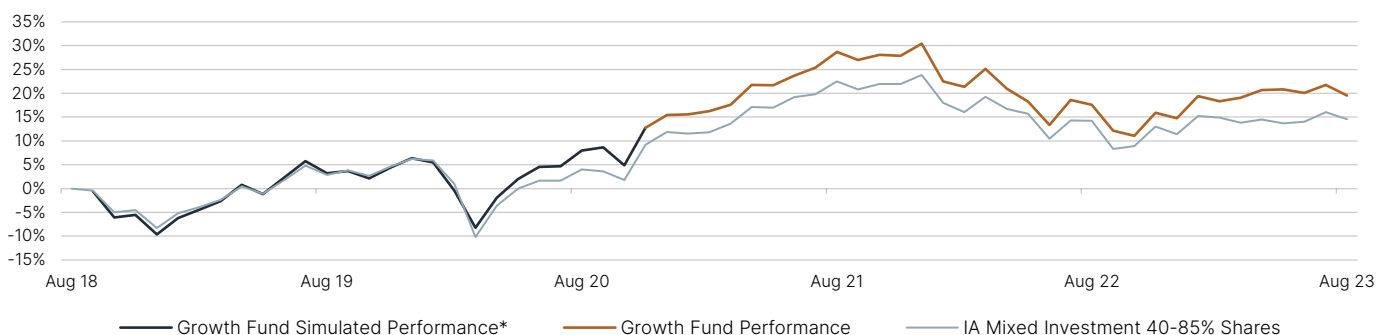
Geographical breakdown (equities)
